
Notice to Sung Tae Hong

ORDER OF NOTICE


The Court has reviewed the Complaint and the Application for First Order of Notice contained therein, which ask for declaratory relief, *inter alia*.

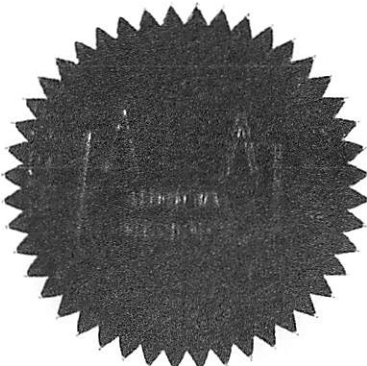

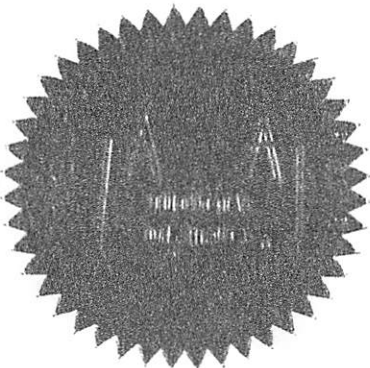
