MOTION

NOW COMES PETITIONER, JONATHAN DAVID KUHN who submits the Application for Order for Service by Publication.

FACTS OF THE CASE

This case is related to the adoption of a minor child as described in the Petition for Adoption of a Minor Child (Stepparent). Petitioner is unable to locate the Respondent, "Any potential/possible father" (see Exhibit "A").

REQUEST

Petitioner has been unable to locate or effect service of process on the unknown father in the above-captioned case. Petitioner hereby requests that the Court issue an Order for Service by Publication for a minimum period of once a week for legal notice in the online consecutive weeks (3) of a website Global Legal Notices®, circulation in The Philippines and surrounding regions which nublication and which provides anadializee hv

numerous benefits over traditional print newspapers (see Exhibit "B"). Their publication policy is to publish the Order, any notices, and <u>all</u> court-issued documents continuously for a period of three (3) consecutive weeks.

ARGUMENT

The father of said child is unknown, therefore, Petitioner has no ability to successfully utilize traditional service of process methods. An unknown father is unavailable for service of process.

The most practical available alternative method of service in such situation is service by publication. The only known method for service by publication in The Philippines is through Global Legal Notices® which provides a more thorough method to give notice to actual the Respondent, an unknown father, as described on their legal notice website at www.GlobalLegalNotices.com.

This method allows for a greater opportunity to give actual notice to the unknown father, the Respondent, than service by publication in a traditional newspaper. It provides publication of the Court Order, plus the entire set of Courtissued documents. Further, the publication period exceeds the customary once a week for three (3) consecutive weeks by continually publishing the documents for an indefinite period, as allowed by law or necessity. In addition, a Google search

by the Defendant's name and country will typically appear on page one of the Google search after approximately five (5) days, thus, providing a greater opportunity to give actual notice to the Respondent, the unknown father.

CONCLUSION

Global Legal Notices® offers an improved method of providing actual notice to a Respondent of a pending lawsuit while satisfying the Court's requirements for service by publication.

It is widely held that service by publication has a limited success rate in providing actual notice to a Respondent that a legal case is pending. Yet, courts routinely issue an order allowing for service by publication in a newspaper, either print or online, as a last resort method to complete service of process.

Wherefore, Petitioner respectfully requests that the Court issue an Order for Service by Publication in this case.
