BY WAY OF BRIEF BACKGROUND, I'M AN ALUMNI OF MARLBOROUGH HIGH SCHOOL AND THE UNIVERSITY OF SOUTHERN CALIFORNIA. IN 2016, WHILE LIVING IN THE UNITED ARAB EMIRATES ("UAE"), I USED MY EDUCATIONAL BACKGROUND TO START AN EDUCATIONAL CONSULTANCY COMPANY CALLED SAGE LEARNING EDUCATION SERVICES LLC ("SAGE"), WHICH REMAINS AN ACTIVE BUSINESS TODAY (WWW.SAGEEDUCATION.AE). ALTHOUGH TALAT AND I FOUNDED SAGE TOGETHER, I AGREED TO HIS REQUEST TO HAVE THE BUSINESS ENTIRELY IN HIS NAME, EVEN THOUGH WE JOINTLY INCURRED DEBT TO START THE BUSINESS AND I EXCLUSIVELY MANAGED THE COMPANY. I ESTIMATE THAT THE BUSINESS IS CURRENTLY WORTH OVER \$1 MILLION USD; ACCORDING TO LAST YEAR'S TAXES/BANK RECORDS, IN 2019 SAGE REPORTED ANNUAL GROSS PROFITS OF APPROXIMATELY \$410,000 USD.

IN 2018, I LEARNED TALAT HAD DIVERTED TENS OF THOUSANDS OF DOLLARS FROM THE COMPANY BANK ACCOUNT FOR HIS PERSONAL EXPENSES WITHOUT MY KNOWLEDGE. ATTACHED AS EXHIBIT "1" HERETO ARE TRUE AND CORRECT COPIES OF BUSINESS BANK STATEMENTS THAT SHOW THOUSANDS OF DOLLARS IN PERSONAL CHARGES AT NIGHTCLUBS, LUXURY HOTELS, AND RESTAURANTS. WITHOUT MY KNOWLEDGE, EXTENSIVE BUSINESS DEBT-UPWARDS OF \$150,000 AED (OVER \$41,000 USD) WAS ALSO INCURRED UNDER MY NAME AND THESE LOAN AND CREDIT CARD BILLS HAVE REMAINED UNPAID SINCE OUR 11/31/2018 DATE OF SEPARATION EVEN THOUGH TALAT OWNS AND OPERATES THE BUSINESS AND THERE IS PLENTY OF MONEY TO PAY OFF THESE DEBTS. THE UAE TREATS UNPAID DEBT AS A CRIMINAL OFFENSE AND IMPRISONS DEBTORS. ALTHOUGH I HAVE RECEIVED NO CHILD OR OTHER SUPPORT FROM TALAT SINCE OUR SEPARATION, ZIA AND I HAVE BEEN ABLE TO RESIDE WITH MY MOTHER IN A COMFORTABLE 3 BEDROOM HOUSE. MY MOTHER HELPS OUT FINANCIALLY AND IS ALSO AVAILABLE TO CARE FOR ZIA WHENEVER I'M WORKING AS A TUTOR.

THE UNITED ARAB EMIRATES IS GOVERNED BY SHARIA (ISLAMIC) LAW, WHERE IT IS NOT UNCOMMON FOR A MOTHER TO HAVE SOLE PHYSICAL AND LEGAL CUSTODY OF CHILDREN FROM INFANCY TO AGE 11, AFTER WHICH FATHERS ARE EXPECTED TO TAKE OVER CUSTODY OF BOYS.

SINCE OUR 11/31/2018 SEPARATION, I HAVE HAD LIMITED COMMUNICATION WITH TALAT BY EMAIL THROUGH HIS SISTER AND TALAT HAS COMMUNICATED DIRECTLY WITH ME VIA EMAIL. IN A RECENT EMAIL, TALAT EXPRESSED THAT ZIA WOULD BE BEST SERVED IN MY SOLE CARE AND CUSTODY. ATTACHED IS EXHIBIT "3" IS A TRUE AND CORRECT COPY OF THAT EMAIL.
